A. Administrator's Report – Highlights of Current Information

1. Bill Updates

Trina Frazier, SELPA Director, updated members regarding AB-428. This bill originally proposed language that would bring the Fresno County SELPA to the 95th percentile for funding. AB-428 was approved unanimously by the Assembly Appropriations Committee and will now move to the Assembly Floor for a full vote. The proposed percentile was lowered to the 90th percentile instead of the 95th. Trina informed members that the Governor's proposal may perpetuate over identification.

Trina informed members that five of the policies of the SELPA Policies and Procedures are being updated. These updates will be provided to SGC next year for a first reading and review.

E. *State Apportionment for 2019-20 Estimate 1

E. Davidson

Eddie Davidson, Fiscal Student Services Director, reviewed the State Apportionment for 2019-20 – Estimate 1. He explained that there are projected increases in expenditures for the County-Operated Program for Special Education. These are due to STRS and PERS rate increases, Salary increases, Health and Welfare increases, Longevity increases, and Step and Column increases. The revenue assumptions included growth of 1.25%, COLA of 3.26%, a deficit factor of 0.97, and MAA funding of \$250,000. The rate-per-ADA allocated to the Members is projected to decrease by 5.69% under Proposal 2. Eddie explained that if the members agree to allow County Operated to use the \$494,693 that is available and reported on the "SELPA Annual Treasurer's Report for 2017-18, Proposed Distribution of Fund Balances for 2018-19," the projected decrease would be 3.40%, which is illustrated in Proposal 1.
