#### VI. \*FCSS Operated Programs Class Size Capacity

C. Borges

Chris Borges, Executive Director of Special Education, reviewed the Class Loading list as of April 3, 2024. We are currently serving 614 students in county-operated throughout 78 classrooms. We are hoping to add a CIRCLE class and an Extensive Supports Needs (ESN) class. The motivation is to keep students as close to home as possible. There are 29 referrals that are pending placement. Chris shared information regarding transportation. The SELPA will still make the offer, but since it's mid-April, we want districts to make those decisions on if student can be served or waiting until August placement. Sometimes we get a referral, but where we have space available may not be close by and have a route available. Perhaps the district can transport, and they can get placed faster. Parent transportation is offered as a last resort.

Chris shared the report titled "Students Served in County-Operated programs which shows how many students are being served and the percentage of the SELPA each district makes up. We are currently operating off of Fall 2022 census data. These numbers will be updated over the summer when Fall 2023 data will be used.
